

**MINUTES OF THE REORGANIZATION MEETING
OF THE TOWNSHIP OF JACKSON
ZONING BOARD OF ADJUSTMENT
JULY 5, 2006**

The July 5, 2006 Jackson Township Board of Adjustment meeting was called to order at 7:45 p.m. with a salute to the flag by all present. Acting Zoning Board Recording Secretary Janice Kisty read the Open Public Meetings Act Statement.
