Dear Resident,

Our Jackson Township Dog licensing policy is as follows: All dogs of licensing age which are 7 months and older must be licensed every year in January. Please complete the form below and return it to the Division of Animal Control with the proper fee. 2010 licenses can not be issued before January 1, 2010. Please make checks /money orders payable to "Jackson Township". Licenses are available by mail or in person ( **NO CASH — PLEASE!** ), between 9:00 A.M and 4:00 P.M., at the Community Development & Enforcement building at 65 Don Connor Blvd. Licenses purchased after April 1, 2010 are subject to an increased fee of \$5.00 as per Chapter 51 of the Jackson Township Code. Failure to obtain a license within the time prescribed by ordinance shall be subject to a fine of not less than \$10.00 nor more than \$50.00, in the discretion of the Judge. Each day's failure to obtain a license will be considered a separate violation.

*Jackson Twp. holds free clinics, watch your local newspapers for dates.*

If you no longer own a dog, you must notify this office by calling Animal Control or by returning the form below

 PLEASE INCLUDE COPIES OF PROOF OF NEUTERING AND OF YOUR CURRENT RABIES CERTIFICATE. NEW JERSEY STATE REQUIRES THAT THE RABIES VACCINATION BE VALID THROUGH OCTOBER 2010 AND BOTH WILL BE RETURNED WITH LICENSE.
