Ceramics –24 registered clients, 3 clients on waiting list. Sessions continue to meet the 2<sup>nd</sup> and 4<sup>th</sup> Monday of each month. One (1) session has been completed.

Helping Hands –35 registered clients. \$1635.54 budget balance remaining.

Challenger Soccer – Saturday sessions starting 9/20/2025 – 10/25/2025 from 9:30 am to 11am. Practices held at the Justice Complex Turf Field. Angelo Losito and family are the coaches for the 2025 Challenger Soccer season. 15 clients registered. \$300 received from registrations. \$0 owed. 2 scholarships. 1 exemption and 13 volunteer buddies. All clients and buddies are required to be checked in at each practice for the ROID Grant for quarterly reporting. \$43.98 for 100 piece soccer themed goodie bag filler; items included are soccer cinch bags, bracelets, keychains, mini soccer balls etc. Additional candy and beverages will be purchased from Costco for the last game. September 27, 2025 practice was cancelled. Final practice has been reserved for November 1, 2025.

Rotary BBQ – Sunday October 5, 2025 from 1 – 4pm at the Senior Center. No rain date scheduled. Chairs handing S. Iorio and Tim from Rotary. Commission members are inquiring for 40 to 50 small/medium pumpkin donations. Blue pumpkins given as a donation will be used as centerpieces. Food choices for discussion are hot dogs. Secretary has secured a 3 dozen donut donation from Jessica (Manager) from the Manhattan Plaza Dunkin Donuts In Jackson. Clients who volunteer to participate in trunk or treat will be exempt registration fee. 47 clients, 56 guests total 103 has rsvp'd. 12 trunk or treat volunteers; \$14 received and \$21 still owed.

Coffee station will be offered. \$2,200 maximum for 200 guests. JTCD/H will provide beverages, paper goods and desserts. Robert with SoManyStylez will be providing music. Karen Powell confirmed 2 holiday sensory tables at the event. Secretary will prepare a photo/video montage for the event. Centerpieces will be pool noodle candy canes, gingerbread houses and Grace has donated lightened trees.
